To enable the Directors to familiarize themselves and experience the manufacturing & other facilities of the Company. The Company conducts an introductory familiarization programme when a new Independent Director joins the Board of the Company.

The Independent Directors also reviewed the operations of the various departments of the Company through the detailed Internal Audit Report in the form of Presentations by the Internal Auditors of the Company.

The Company shall also provide regular updates on relevant changes in Company Law and the Listing Agreement to ensure that its Independent Directors are kept update on these regulations.
